New Student Application & Enrollment Fees

The non-refundable Application Fee must be submitted with the Student Application. This fee is assessed to any student not enrolled in Shoreline Christian School during the previous school year. The online Enrollment Fees for new students are due 14 days after admittance date.

Current Family Reenrollment Fee

Capital Improvement Fee

Multiple Student Discount

- 2 students – total tuition is reduced by 4%

Withdrawal Fees and Costs

Early withdrawal fee for any student (Preschool through Grade 12) will be \$100 per student. Students who withdraw during the school year will also be liable for tuition prorated through the end of the month of withdrawal. For calculation purposes the monthly tuition will be set at 1/10 of the annual tuition amount.

Payment Options

Payments may be made annually, quarterly, or on a ten or eleven month plan. Please contact the business office for details.

A 1.5% discount to tuition is offered for accounts that are paid in full with cash/check before **9/01/18**. (The 1.5% discount does not apply to the Capital Improvement Fee, Application Fee or Registration Fee.)

Visa/MasterCard/Discover/American Express may be used to pay tuition and fees. The 1.5% discount for payment in full prior to September 1 does not apply when using a bankcard.
